#### **COMMITTEE REPORTS:**

### ADMINISTRATIVE AND FINANCE COMMITTEE REPORT: Mr. Hill

Robby Hill announced the committee met and has completed the Airport Director's Performance Evaluation.

Robby Hill read the April 2024 Flow Sheet as previously emailed.

#### **AIR SERVICE COMMITTEE REPORT:** Mr. Nettles

Connie Anderson read the April 2024 Enplanement Report and Load Factor History Report as previously emailed. There was brief recap of the meeting with the new Air Service Consultant's meeting with American Airlines in follow up to the letter to business leaders who were in attendance at the Chamber of Commerce business leaders breakfast asking and reminding them to support the airport and fly Florence. There was discussion.

# PROPERTIES AND PROJECTS COMMITTEE REPORT: Mr. Josey

Judy Elders reported the FAA has approved the final payment, and the contractor has been paid. Once TBE receives the as-built survey from the surveyor, TBE will produce Record Drawings and begin to closeout the grant.

On the Rehabilitate Taxiways B, B-3, B-4, and D (Construction), Palmetto Corp. of Conway (contractor) mobilized on Monday, April 15, 2024. All work on Taxiway B4 is complete. The work on Taxiway B3 is mostly complete, except for the tie-in at Taxiway D. Taxiway B has been completely paved, but a portion of the pavement markings remains to be completed. The surface hold markings and lead-in lines to Runway 27 remain, because the marking subcontractor, HASCO, got rained out before they could finish.

TBE is putting together the PFC application to submit to the FAA for review and approval prior to scheduling meeting with airlines.

On the Runway 09/27 and Taxiway Rehabilitation the grant application was submitted to the FAA on May 2, 2023. The CATEX was to FAA on May 10, 2024, and received FAA approval May 10, 2024. Grant certifications were submitted on May 13, 2024.
